## 2022 CLFLWD Board Meetings and Permit Exhibit Deadlines

Permits for erosion control alone can be issued administratively, meaning they do not require approval from the District Board of Managers. If any other District Rules (e.g., stormwater management) are included in the permit, the application must be approved by the Board of Managers at one of their public meetings. All exhibits must be submitted to the District 30 days prior to the next board meeting in order to be put on the manager's agenda.

In 2022 all regular board meetings are scheduled to be held at 6:30 p.m. on the second and fourth Thursday of the month except for November and December, when one meeting will be held on the third Thursday of the month. Meetings on the second Thursday of the month are subject to cancellation based on the needs of the Board. **In response to the ongoing COVID-19 pandemic, all meetings will be held via online video conference until further notice.** Call-in instructions will be provided in each meeting notice and on the District website. Please advise the District Administrator in writing or by email ([michael.kinney@clflwd.org](mailto:michael.kinney@clflwd.org)) if you would like to receive notice of meetings and meeting cancellations.

Additional board meetings may be held throughout the year. However, these meetings are largely for discussion purposes only and are subject to cancellation. Permit applications will not be reviewed at these meetings unless special circumstances require.
