COST-SHARE APPLICATION INSTRUCTIONS

Comfort Lake – Forest Lake Watershed District has three cost-share programs for 2026. Please follow the below instructions for applying.

2026 Programs:

Mini Grant – This program provides a reimbursement of up to \$500 for small projects that improve water quality or habitat. Applications are accepted year-round and are reviewed on a first-come first-served basis.

Shoreline Habitat Incentive Program – This program provides flat-rate incentives for shoreline improvements. The maximum payment is \$1000. Applications are accepted year-round and are reviewed on a first-come first-served basis.

Community Water Cost-Share - This program will cover up to 75% of a project, with a max amount of \$8000. Eligible projects for this program include rain gardens, shoreline restorations, native plantings, and other projects that improve water quality. This program is competitive and only the projects with the highest cost-benefit and greatest impact will be funded. Applications are accepted year-round with two review windows. Applications received from February through July will be reviewed and decisions announced in fall; applications received from August through January will be reviewed and decisions announced in spring.

To Apply:

- If you have not consulted with CLFLWD staff prior to an application, it is recommended that you follow up to request a site visit or to discuss the project prior to applying.
- Fill out the application with personal information and details about your project. Check ONE box, either the Mini Grant, or the Community Water Cost-Share (see above).
- Attach project plans – This can be a rough sketch, a plan by a contractor, or a thorough narrative description of the project.
- Maintenance Covenant: *This option is for the Community Water program only.* Signing a maintenance covenant ensures you maintain the project for the intended lifespan (usually 10 years). This is not required but will make your application more competitive.
- When your application has been received, staff will acknowledge receipt with an email or phone call. Applications will be reviewed as described above.
