RE: Administrator's Report for the April 23, 2026, Regular Board Meeting

Administration (1000 series)

- 1003 – General Administration
 - Minnesota Conservation Corps Member, Kennedy Kolb, started with the District April 2. The serving term is April through October. Kennedy will support the District's water quality monitoring, nonpoint source pollution abatement, and education & outreach programs and has already demonstrated that she will be a valuable member of the District's team.
 - The District submitted an application to the MN Pollution Control Agency (MPCA) for Loan E on February 19th. Staff have checked in with MPCA a couple of times since then, and MPCA indicated its loan review committee is still reviewing the District's application. The District cannot begin to incur eligible expenditures for loan reimbursement until the loan agreement is executed, which will occur within a few weeks of the notice of award, if the loan is awarded.
 - Special Districts can celebrate the first ever National Special Districts Day on May 6, 2026! NSDA honors nearly 40,000 Special Districts across the United States by creating a first ever National Special Districts Day, on May 6th, 2026. Special Districts day coincides with the NSDA's 2026 Special Districts Days in Washington, DC where we pre-arrange congressional and Executive Branch Office visits with special district leaders from across the Country that provide essential services to their communities.

Programs (3000 series)

- 3002 – Permitting
 - Between March 17, 2026 and April 10, 2026, the following activity took place:
 - 101 site inspections performed with a 95.25% compliance rate.
 - Seven permit applications were received
 - Three permit applications were approved and no permits closed out.

- 3003 – Monitoring & Data Assessment
 - CAMP lake monitoring began the week of April 20th.
 - Lake staff gages and lake level loggers installed the week of April 13. Real time lake elevations are available online @ <https://clflwd.org/lake-levels/>
 - The 2025 Comprehensive Monitoring report was approved by the CLFLWD Board of managers at the April 9th board meeting. It is available to the

public through the District's online document library <https://clflwd.org/documents/> by using the key word search "2025 comprehensive monitoring report."

- 3004 – Non-Point Source Pollution Abatement (Cost-Share)
 - Staff continue to conduct site visits and process cost-share applications. Six projects have been approved so far in the 2026 season
 - Residential soil testing has begun, staff have been collecting samples for testing at the University of Minnesota's soil testing laboratory. Results will be passed on to residents to help inform lawn management decisions.
 - The Farmer-led Council will have a farmer coffee hour on Thursday 4/16 featuring a guest speaker, Jeff Mallery of Mallery Jerseys.

- 3005 – Education & Outreach
 - EO Coordinator Hjelm, in coordination with Forest Lake Community Education, put on a family education class on native bees and host native plants. 10 people were in attendance.
 - EO Coordinator Hjelm, in coordination with the Hardwood Creek Library, put on a community education class focused on spring native plants and garden design. 15 people were in attendance.
 - The Bone Lake South Nature Area Informational Meeting was held at the Scandia Community Center. 62 people were in attendance. CLFLWD staff Blayne Eineichner, Aidan Read, and Mike Kinney were presenters. Manager Dave Bakke welcomed the crowd before the main presentation took place.
 - The third session in the Watershed Connections lecture series, Climate-resilient Trees for a Changing Landscape, was held on March 16 at the Forest Lake Senior Center. 20 people were in attendance. The next event in the series, How Zebra Mussel Populations Affect Mercury Accumulations in Fish, is scheduled for April 27th from 6 to 7:30 p.m. RSVPs are due April 24th. <https://clflwd.org/event/watershed-connections-how-zebra-mussel-populations-affect-mercury-accumulation-in-fish/>
 - The Natural Shoreline Outreach Campaign continues to make steady progress and meet performance metrics. The reels/videos can be

- 3006 – Interagency Communication
 - Lower St. Croix Watershed Partnership (LSCWP): The LSC Policy Committee’s next meeting is Monday, April 27th. The LSC Planning Team will next meet on April 29th. The LSC Steering Committee last met on April 8th and discussed project funding requests, the mid-point evaluation, and preparations for the FY27 Watershed Based Implementation Funding grant work plan. - 3007 – Research
 - The UMN Lake User Survey of Forest Lake will begin again this spring. Signs were placed at all the Forest Lake boat launches in 2025. Staff will work to advertise this survey to lake users to support this research effort. Notice of the survey will be shared with the Lake Association and Watercraft inspectors will promote the survey while staffing the boat launches this summer.

- 3008 – Measurement of Progress
 - The 2025 Year-In-Review, Annual Report, and Progress Report are on the April 23rd agenda.
 - The Board of Water and Soil Resources (BWSR) is reviewing materials and working on the CLFLWD’s Performance Review & Assistance Program (PRAP) assessment report. Part of the PRAP assessment is a partner survey which occurred from February 17th to March 3rd. BWSR staff has indicated that the survey had an 87% response rate, which is very good. The PRAP assessment report and a presentation by BWSR will be brought to a future board meeting once BWSR has completed its assessment.

- 3009 – Grant Research & Preparation
 - Section 319 Small Watersheds Focus: The District has been allocated \$279,583 as part of its second scheduled installment through this grant program. Four years ago the District was approved to participate in this program and receive stable grant funding every 4 years for a 16-year period. The District will work closely with MN Pollution Control Agency staff to prepare the work plan and obtain approval from the Environmental Protection Agency. We anticipate grant funds will be available at the end

of this year or early 2027. Funds can be used on a variety of water quality work such as water quality improvement projects, education & outreach, and effectiveness/progress measurement monitoring (but not diagnostic monitoring). Since this is a federal grant, it may be utilized as match funding for state grants, such as Clean Water Fund grants, provided that expenditures are eligible and occur within the grant agreement period.

- The District was awarded a \$5,000 grant through the DNR's No Child Left Inside grant program. This is a new grant program for the CLFLWD. This grant will fund the purchase of education kits to be utilized for youth outreach in partnership with local schools.
- 3010 – Operations & Maintenance
 - The CR50 Iron enhance sand filter was activated on April 10th.
 - Staff installed weir boards at the Bone lake inlet and at Bixby Park on April 17th.
- 3011 – Aquatic Invasive Species Prevention & Management
 - Watercraft Inspectors have begun the required DNR training that will ensure a successful 2026 season. The District will have a team of 8 seasonal staff members along with a Conservation Core member. The planned WCI season will begin May 8th and continue until the October 18th.
 - Blue Water Science has started spring Curly-leaf pondweed (CLP) delineations. Bone, Comfort, & Shields were surveyed the week of April 13th, & Forest Lake was surveyed the week of April 20th. District staff contacted DNR and they are putting May 15th for expiration dates on current MPARS CLP management permits. The DNR will be monitoring CLP growth and water temperature, which may shift the expiration dates earlier. Note: District staff will be performing the initial CLP delineation for Moody Lake following standard meander delineation survey protocols.
 - Staff have performed the initial review of the District's AIS Rapid Response plan. The purpose of this is assessing the District's response to potential new AIS infestations, with a focus on Starry stonewort. Staff visually inspected the floating silt curtain barriers that are stored at the Forest Lake Public Works maintenance facility. Along with reaching out to any

contacts that staff do not communicate with on a regular basis, updates have been made accordingly.

- Staff have attended the offseason WCI workshop hosted by the DNR. Various topics were discussed that related to AIS management, prevention within and across borders, successes and cuts to prevention aid funding, & partnerships.
- The required Prohibited Invasive Species Permit has been obtained for the Purple loosestrife biocontrol efforts that District staff will be implementing in 2026. This allows an individual to collect, possess, and transport Purple loosestrife for biological control purposes. District staff joined Wild River Conservancy staff during a rootstock collection event that they hosted, following DNR guidance and regulations. - Researchers from the University of Minnesota are looking to obtain samples of adult zebra mussels from Comfort Lake & Bone Lake for a genomic study related to zebra mussel pathways and distribution patterns for Minnesota lakes (Forest Lake specimens were previously obtained). This builds upon previous analysis study and researchers plan to extend this analysis to more than one hundred lakes in Minnesota. - 3012 – Land Acquisition
 - The Bone Lake South Nature Area Management plan development is currently underway. Staff will develop a draft for review by EOR and submission to the Board for review later this summer.
- 3013 – Watershed Planning & Resiliency
 - Two planning items are on the April 23rd regular meeting agenda: Floodplain Resilience Action Plan and Watershed Management Plan Minor Amendment.

Projects (5000 series)

- Moody Lake
 - Capstone: staff will be installing the informational signs at the Moody Park in the next few weeks. The signs describe the restoration efforts implemented and their benefit to the ecology of the lake.

- Little Comfort Lake
 - Heath Ave IESF: Bids for the project were opened on April 14th. Eleven bids were received, with several aligning with the engineers' estimate and budget for the project. Staff and EOR are reviewing the bids, contractor references, and required contractor experience, and will bring a recommendation before the Board at the May 14th Board meeting.

- Forest Lake
 - North Shore Trail Nature Area: A prescribed burn was successfully carried out on Friday April 10th. District staff will monitor the results of the burn along with our partners at Great River Greening. Remaining tasks for this phase of restoration include seeding and plug installation. The grant funding the restoration ends in June 2026.

- Comfort Lake
 - East Comfort Pond: As part of the Feasibility phase for the project, on April 13th EOR surveyed the pond and surrounding project site and collected soil samples from the stormwater feature. Staff have begun the landowner outreach for the project.
